### **Provincial Engagement Initiative**

**Purpose**: Strengthen a collective voice for settlement in Alberta, identify system challenges and share information to facilitate collaboration, research, advocacy, and engagement across the sector.

Structure: Quarterly meetings held for the following committees: Small Centres, Edmonton, Calgary

Working language: English (but see Groupe de Travail Provincial for French-only meeting)

### **Groupe de Travail Provincial**

**Purpose**: With an identical structure to the Provincial Engagement Initiative, this meeting series brings together Francophone agencies and agencies with French services to share success and challenges and facilitate activities.

**Structure:** Quarterly meetings

**Eligibility to attend**: Must apply to join a committee. Terms begin in October. During a term, prospective committee members may reach out to <a href="mailto:events@aaisa.ca">events@aaisa.ca</a> at any time to apply.

Working language: French

#### **Alberta Settlement Sector Call**

**Purpose**: Quarterly call held to support increased collaboration, coordination, and communication between IRCC, the Government of Alberta, RIFA, and Alberta's settlement and integration sector at large.

**Eligibility to attend**: Open to all IRCC funded SPOs in Alberta.

Working language: EN/FR interpretation



#### **Small Centre Quarterly Call**

**Purpose**: To keep Small Centre agencies across the province connected, and to share emergent challenges, relevant updates, and best practices to strengthen our collaboration and collective impact in the province.

Eligibility to attend: Open to all Small Centre IRCC funded SPOs in Alberta.

Working language: English, generally without interpretation funded

## Refugee Assistance Provider (RAP) Calls

**Purpose**: Discuss and coordinate our response to refugee resettlement between IRCC, the Government of Alberta, and Alberta RAP Providers.

**Eligibility to attend**: Open to all designated RAP Provider in Alberta. Open to coordinators, managers, and other senior staff.

Working language: English, generally without interpretation funded

### **IRCC Language Deck Call**

**Purpose:** Presentation of the IRCC Language Deck and discussion of waitlists, intake numbers, new program policies and initiatives, funding agreements, executive directors, and other high-level trends within LINC/CLIC programs.

Eligibility to attend: Open to all IRCC funded LINC/CLIC providers in Alberta.

Working language: EN/FR interpretation

## Alberta Quarterly Language Sector Call (AQLSC)

**Purpose**: A quarterly discussion of gaps, opportunities and trends occurring in front line delivery of LINC/CLIC programming. AQLSC provides a space for providers to share best practices, new resources, and collaborate with other LINC/CLIC providers

**Eligibility to attend**: Open to all IRCC funded LINC/CLIC providers in Alberta. Open to coordinators, managers, executive directors, and other senior staff.
